## SPECIAL CONDITIONS

## DINNER

- Drinks included: water, soft drinks, beer, wine (up to a maximum of 1/2 bottle per person) and coffee. The beverage service ends with dessert.
- Prices and suggestions valid until the 30th of December, 2021, except December 24, 25 and 26.
- Restaurant closing time according to government guidelines.
- Menu valid for groups with a minimum of 10 people (adults).
- The approximate number of people participating in the events must be informed in the reservation and a 30% payment must be done in order to confirm the reservation.
- The final number of participants and the remaining 70% the total amount must be guaranteed up to a maximum of 3 working days before the event date. This will be the final number for billing and payment purposes. If the number of participants is greater than guaranteed, billing will be updated accordingly.
- In the event of a 50% (or more) reduction in the number of people from the time of booking until the final confirmation, Hotel Faro may apply a penalty corresponding to 50% of the value of canceled meals.

## GENERAL INFORMATION

### Food and Drinks

No food brought by the organizers or their guests may enter the Hotel, without prior written authorization from the Hotel Management

### Use of Restricted Areas

No fixing to floors, walls, ceilings and columns with screws, tape or other means for suspension in the ceiling or wall, nor remove objects of the existing decoration.
